ARTICLE I - Name

The name of this corporation is: CALIFORNIA FLY FISHERMEN UNLIMITED.

ARTICLE II - Purpose and Powers

- A. This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes.
- P. The specific purpose of this corporation is:
 - 1. To educate anglers in the art of fishing with artificial flies and in the practices of sports-manship and conservation.
 - To conduct education activities to bring to the general public information on fly fishing and on conservation and improvement of fishery and water resources.
 - 3. To study and make recommendations on government fishery and resource policies which affect fly fishing quality and opportunities.
- C. The general purpose of this corporation is to have and exercise all rights and powers conferred on nonprofit corporations under the laws of California.
- D. Notwithstanding any other provision of these articles, the corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or (b) by a corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.
- E. No substantial part of the activities of this corporation shall consist of carrying on propaganda or otherwise attempting to influence legislation, and the corporation shall not participate or intervene in any political campaign (including the publishing or distribution of statements) on thalf of any candidate for public office.
